**THIS IS ISSUED SUBJECT TO THE FOLLOWING CONDITIONS:**

1. Any burning must **only take place in an outdoor enclosed fireplace.**
2. Burning is limited to clean, dry wood or charcoal.
3. There must be an attendant at the scene of the fire, and the fire must be completely extinguished before the attendant shall leave
4. No person shall set or maintain a fire in a fireplace unless he or she ensures all of the following conditions are met:
  - a. The fireplace:
    - i. Is not located on a balcony;
    - ii. Is not located on any combustible surface;
    - iii. Is in good working order; and
    - iv. Is located at least three (3) metres from any building or structure;
  - b. All openings in the fireplace are completely covered by metal wire mesh with grid openings no larger than 12 millimetres in diameter;
  - c. The fire is confined to the fireplace;
  - d. The person burns only clean dry wood or charcoal in the fireplace; and
  - e. The person sets and maintains the fire in the fireplace only during the time falling between two (2) hours before sunset and two (2) hours after sunrise of the following day, unless such person has the prior written consent of the Fire Chief to set or maintain the fire in the fireplace during any other time.
5. The undersigned applicant hereby acknowledges that fireplaces must be at least 3 metres from any buildings or other structure, including fences.
6. The undersigned applicant hereby acknowledges that the Community will not be held responsible for conditions which may cause the blowing of sparks, ashes, and/or smoke.
7. The undersigned applicant hereby acknowledges that in the event that any of the forgoing conditions are not complied with, this notification shall become null and void and the undersigned applicant shall be liable for any damage to public and/or private property caused by the fire and shall also be liable for the full cost of extinguishing the fire.
8. The undersigned applicant acknowledges that this notification is issued pursuant to By-Law Number 14-16 as subsequently amended, and that every person who contravenes any provision of the said By-Law is guilty of an offense and shall, be liable, upon conviction, to the penalties provided by the Provincial Offenses Act R.S.O. 1990, C P33 or any legislation in succession thereto.
